## **DRIVING LICENCE CODES**

A driving licence may carry codes for driving entitlements and restrictions. You will not be able to retrieve a driving licence record when the licence carries codes imposing restrictions due to medical reasons.



Here you find an overview of all codes in use. You can see which codes allow you to retrieve valid driving licences and which codes do not, and which codes will be displayed when you successfully retrieve a driving licence record.

Different codes may carry the same text, as previously used codes have been replaced by new ones. Whether a driving licence carries the new or the old code depends on its date of issue.
